R: Water play. Children are close to water ways (deep water, tides, big and strong waves)B: Children aware of water safety and how to behave near water. They will learn to watch and assess the wave activity.	Low	The educators have spoken to the children about the boundary when at the beach, strictly setting the rules that no one is allowed to swim in the water, we only swim at the beach with our parents. An adult will always be present when children are close to any water, splashing of feet or in rock pools will be determined by each staff member. Children will be provided with information on rules and hazards when near the water, including listening for the whistle or verbal commands as well as visual commands. When close to the water staff will examine the conditions of the waves and determine the activities that will be appropriate (splashing of feet or exploring small rockpools) or the route that is the safest when walking along the beach. 
R: Dogs off Leash - Dog bites, balled over by/fear of dogs causing psychological damage B: Children learn about risk and consequences of taking risk. Access to the rich outdoors fulfills children's need for excitement and provides safe avenues to explore risks\Active outdoor play helps avoid illness associated with reduced activity levels (obesity, cardiovascular, respiratory benefits) Children have opportunity to engage in active play that requires large motor movements, unmatched in any other environment. Minor injuries allow children to develop resilience and ability to assess their behaviour and evaluate what they would do in the same situation next time. These strategies help them when faced with serious risk and complicated challenges in the future. Risk taking fosters learning (Flinders Ocean beach and most of the Pier Beach prohibit the presence of dogs. To the left of the pier heading away from the Yacht Club, there is a small area where dogs are allowed. Beach Kinder sometimes walks passed the dogs beach.)	Moderate	Most children have been pre exposed to dogs by introduction at local parks or as family pets. Staff will provide dog awareness training to children before starting beach kinder. Staff will teach children to stand still, with their arms by their side if approached by a dog. This will be practiced as a drill on going.
